## Grades:

Grades will be based on two exams and 2-3 home projects (the last of them will be a research paper).

Home projects contribute to 20% of your grade (15% for the program and 5% for the paper). Late home projects will not be accepted. No collaboration is allowed on home projects. During the test I can show you the printout of one of your home projects and ask some questions about it (or related to it). A failure to answer any of these questions will lead to a severe test penalty and 0 points for the home project itself. Home projects should be submitted ONLY through Blackboard unless instructed otherwise.

Home projects are for home work only. You are not allowed to work on your home projects anywhere in CUNY. Use remote connection to check your project on Linux Lab computers. The only time your work can appear in public in Hunter is when you bring it to me for a review.

Breaking this rule leads to 0 points for the project and heavy final exam penalty. If you believe you need an exception to this rule, come talk to me.

Stealing other people's work is considered an especially heavy crime. The Office of Student Conduct suggests expulsion from college and note on transcript to be a penalty for such stealing. I fully uphold this suggestion.

Midterm exam will be announced at least one week in advance. It is worth 40% of your grade.

The Final will be given during the scheduled final period and will obey the official Hunters final schedule. The Final will be 40% of your grade. Final will be cumulative.

There will be no "extra credit" assignments. There will be no chance to pull up your grade by doing additional work. All grades are assigned following the same criteria.
