## Course Description

This course is an introduction to some of the popular tools used for fullstack web development. It is meant as an opportunity for Computer Science students to: build their online portfolios; practice working collaboratively with peers on the same codebase; learn about tools for fullstack web development, so that they continue to work on personal projects after completion of the course.

**Prerequisites:** Students must have taken CSCI 235 before taking this course. It is recommended that you are very comfortable writing and testing code on your own, and have basic experience with git/GitHub, JavaScript, HTML, and CSS.

- JavaScript, HTML, and DOM Manipulation
- ReactJS
- React-Redux
- Making external API requests
- React Router and client-side routing in a SPA
- Node.js

- ExpressJS and RESTful APIs
- PostgreSQL/Sequelize ORM
