

Math 150: Calculus with Analytic Geometry I – Spring 2021

Textbook: Essential Calculus, 2nd Edition by Stewart, Cengage Learning

Prerequisites: A grade of C or better in Math 125 (Pre-Calculus). Students are expected to be familiar with algebra and trigonometry.

Expected Learning Outcomes:

The student will learn about functions of one variable, including the concepts of limit, continuity and the derivative. The student will be able to compute derivatives of various functions such as polynomials, rational functions, trigonometric functions, exponential and logarithm functions. The student will learn the Mean Value Theorem as well as the Intermediate Value Theorem. These concepts will be applied by the student to various problems involving related rates, curve sketching and optimization, and linear approximation. The student will learn about antidifferentiation and the Riemann integral, and will be able to compute Riemann integrals of some simple functions using the Fundamental Theorem of Calculus. Finally, the student will apply these techniques to computing areas.

Topics covered: We’ll be covering chapters 1 – 7, though not every section will be covered. The chapters and sections are as follows:

1.3 – 1.6, 2.1 – 2.8, 3.1 – 3.5, 3.7, 4.1 – 4.5, 7.1 – 7.3

Homework: (10%)

There will be homework assigned, worth 10% of your grade, which will be given online after a section is covered. Students will be using Lumen (register on <http://ohm.lumenlearning.com>) to do their homework. Homework is meant to help you understand the material, and these assignments are for your own benefit. Extensions will **NOT** be granted.

The class ID you'll enter when you register is **50780** and the enrollment key is **hunter m150 sp2021**. You are encouraged to work on them as soon as possible.

Exams: (90%)

There will be 3 exams, on Lumen, which will cover the material from the topics covered. A missed exam will result in a score of 0.

Final Exam:

The final exam is required for every student; no one is exempt from taking the final exam. The final exam will be cumulative. The final exam score will be counted twice into determining your final grade. Information regarding the final exam date and time will be given later in the semester.

Grading:

Your end of the semester grade will be determined by homework and exams. 90% of your grade will come from your exam scores and 10% will come from homework assignments. The letter grade to be recorded on your transcript will be determined by the Hunter College grading system:

Details regarding grading:

Since the final exam will be counted twice, each student will have 5 scores. Out of these 5 scores, the lowest score will be dropped, that is, that score will not be counted into determining the final grade. I will take the average of these 4 scores, and then take 90% of the average.

Since an exam score gets dropped, **there will be no make-up exams**.

Credit/No Credit and Incompletes:

Students may request to receive Credit/No Credit (CR or NC on your transcript) instead of a letter grade. Anyone on probation is not eligible to receive CR/NC.

At the end of the semester, if your grade is at least a 70, you will receive a CR on your transcript. If your grade is equivalent to a D, you have the option to decide whether you want the D or go for an NC. Anyone whose grade is equivalent to an F will receive an NC.

To receive an incomplete (IN), a student must have taken at least two of the in-class exams, have a C average on those exams, and a legitimate excuse for missing the final exam.

Withdrawal:

At any time up to the withdrawal deadline, students may withdraw from the course with a grade of W on their transcripts. It is your responsibility that you take the necessary procedures to officially withdraw from the course. If you stop attending and have not officially withdrawn from the course, you will receive a grade of WU instead.
